The City of Ferndale collects taxes for other jurisdictions and taxing agencies. These assessments are consolidated on your statement for your convenience, with the collected money sent to the other jurisdictions. For each dollar of your winter property taxes:

### 45¢ goes to Oakland County Transit

Operates, maintains, improves, and expands public transportation services in Oakland County.

#### 31¢ goes to Oakland County Parks and Recreation

Improves, operates, and maintains parks, open space areas, trails, and recreation activities in Oakland County.

# 10¢ goes to Huron-Clinton Metropolitan Authority (HCMA)

Operates the 13 Huron Clinton Metroparks in five counties: Wayne, Oakland, Macomb, Washtenaw, and Livingston.

#### 9¢ goes to the Detroit Institute of Arts

Provides funding to the Detroit Institute of Arts for the benefit of residents of Oakland County.

## 4¢ goes to the Zoo Authority

Provides continuation of zoological services at the Detroit Zoo to benefit the residents of Oakland County.
